WORLD CIVILIZATION FROM NOAH

GENESIS

The Bible and the Mexican Codices both offer accounts of the creation of the world. However, in this book, we take a different approach, starting not at the beginning but at the point of the **last global reset** – the great flood. Many nations and scientists believe that this catastrophic event took place around 5,000 years ago. Within this calamitous event, one man and his family – Noah, his wife, and his three sons – played pivotal roles in repopulating the earth. The reason for God's choice of Noah's family was their genetic purity, unlike the rest of the world, where corruption had spread to people, animals, and even plants.

Noah's three sons were **Shem**, **Ham**, and **Japheth**. We have come to realize that there is a difference between being **misinformed** and **uninformed**. The key to understanding lies in intent. One must examine inconsistencies, discrepancies, and relevance through multiple sources or lenses in order to discern the mentality and intent of the author.

CAUSE AND EFFECT:

- In addition to using math and geometry, how can languages other than DOS, C++, Java, Python, French, Russian, and Asiatic languages be used in programming?
- Why can't languages such as Haitian Creole and Swahili be used in programming?

Starting from **World War I** (1918-1940), world technology progressed at an exponential rate. We transitioned from a mechanical phase of understanding electricity to what seems like incomprehensible "magic" that allows humans to communicate metaphysically and animate inanimate objects, like your computer.

At this pivotal moment during WWI, an imbalance occurred following the sacrifice of so many lives. It is during this time that the programming of energy through auditory and visual frequency manipulation began. This metaphysical imbalance needed adjustment, which was achieved in **1970** with the discovery of the **Dead Sea Scrolls**. These writings reaffirmed the spiritual connection to the manipulation of "dead" elements, revealing its origins, evolution, and ultimate purpose. There are **225 copies** of manuscripts, dated between **150 BCE and 70 CE**, tied to the destruction of Jerusalem by Emperor Titus and General Vespasian. This includes the **Books of Jasher**, **Jubilees**, and the **Book of Enoch**, all of which were omitted from the Old Testament during the **Council of Nicaea**. These texts, suppressed by the Vatican, are crucial to understanding the original narrative of the Bible. The 66 books salvaged from these manuscripts were ultimately adopted to validate the new Christian Bible.

The most popular Christian Bibles, such as the **King James** and **Louis Segond** versions, are based on the **Hebrew Masoretic Text**, a Jewish-translated and modified version of the original scriptures. However, earlier translations differ significantly in their timeline events and other details. The discrepancies are so vast that they have led to numerous interpretations and created diverse religious factions. Many people, however, blindly follow these versions without questioning their authenticity or legitimacy. Today, we have the internet to compare and access different Bible versions. The question still remains: How can one discern the real facts from these varying sources?

HISTORICAL CONTEXT AND THE CRITICAL TIMELINE

Historically, the recording of events began with **Enoch**, the fourth generation from Adam. Many ancient civilizations can trace their history back 4,000 to 5,000 years. From **Noah**, through **Shem**, **Heber**, and the patriarchs **Moshe**, **Abraham**, and **Jacob**, a distinct covenant with **Yahawah** was established. Heber referred to his people as the **Hebrews**, and Jacob's descendants became the **Israelites**. This lineage remains significant due to the actions and successes of **Yahawah** in contrast to other gods worshipped at the time. Their recorded history and covenant have made the nation of **Israel** one of the most influential peoples under God.

CRITICAL TIMELINE JUSTIFICATION

Is it a discrepancy when the **Hebrew Masoretic translation** indicates that **Shem** outlived his entire family? This could have resulted in significant emotional distress. In all other translations, each father from Shem to Abraham passed away before their children, and adding an extra 100 years to their ages, as seen in prior translations, follows a more conventional and natural pattern of succession.

The inconsistencies are numerous, not limited to the timeline. These discrepancies add about 1,000 years to the current chronology. They also include the migration patterns of peoples, locations of significant events, and even the names of God. We are uncovering hidden information, such as evidence of Americans speaking **Hebrew** and documents revealing the presence of **Phoenicians** and **Moors** in the Americas the **Inquisition**. These findings have been kept secret in institutions such as the **Smithsonian** Library, alongside indications of the influence of **Constantine** and **Viking art** in the Americas. Could **Amaraka** be a reference to a much older history that intertwines with the biblical accounts of migration, the dispersion of peoples, and the rise of various ethnic groups around the world?

AMERICA OR AMAROU KA3', ITS DECEPTION AND ETIOLOGY CLARIFIED.

Western historians often credit Amerigo Vespucci, the Florentine mariner originally named Alberico Vespucci, with the naming of America in 1499. This assertion was made public in a famous letter by Bishop Florentine and was further supported by the German cartographer Martin Waldseemüller in April 1507, which was a step toward promoting the idea of a heliocentric globe or a round Earth. Interestingly, it was only after this period that Vespucci began signing his name as Amerigo. Contrary to this claim, it has

long been known that the inhabitants of South and Central America were already using the name "Amarouka."

However, the etymology of "Alberico" is derived from "Albert." It's a common practice for people to use their last names to mark their discoveries. Nevertheless, we can associate the term "America" with the group of aborigines living in the Montagne Range Amerrique and their tribe called the Amerriquan in Nicaragua, disregarding Amerigo Vespucci as the sole originator of the name "America."

● Upon finding the origin of the name and meaning of the land, we realized the similarity of the origin of the word "Egypt." Egypt⁴ was called by its People "Tamen or Tameri" (beloved land) and "Aeria" dark dirt, also other name exist like "Ta-Akht" (fertile soil or "Kmt" (black Soil). The Term TA-Meråu is express to be the people of the land of the Nile-flood, ie the Egyptians.

*These statements indicate that the term "America" has historically been associated with Ancient Egypt, making its biblical reference plausible. In the scientific community, some of the oldest sedimentary rocks have been discovered in the Laurentian Mountains in Canada, suggesting that the Americas are among the oldest continents to emerge after the flood. While it's important to note that carbon-14 or argon dating of rocks can be inaccurate due to the challenge of precisely determining when these elements were first energized, we will consider this relevance for the sake of reference.

HOW RELEVANT IS HAITI?

THE MIGRATION AND ORIGINS

The name of a tribe is highly significant. It can define a region, but more importantly, it often reflects the identity of the tribe's father or leader. *Hayiti* is one such example. Originally known by its aboriginal name—either *Iti-Ah* or *Iti-Ya*—the island was renamed *Hispaniola* by European colonizers. For 400 years it carried this imposed name until Jean-Jacques Dessalines formally restored its indigenous name: **HAYITI**.

This name is also a Hebrew term that signifies the past tense of the verb "to be": hayiti, meaning "I was." In Hebrew, this is how one might refer to oneself in the past, as hayiti — both rooted in the same verb. Let me explain: the Hebrew verb "to be" (היה – hayah) and how it's used in past tense, specifically "hayiti" (היה), meaning "I was". The verb "hayah" (היה) in its different forms (like hayiti, hayah, hayta) is foundational in biblical and modern Hebrew, and you're using it here to draw a deeper linguistic and

cultural connection to the name *Hayiti/Haiti*; in general has been remouved from the bible.

Christopher Columbus's translator, Luis de Torres—born Yosef ben HaLevi HaIvri, a Jew and Aramaic speaker—documented that the natives of Haiti spoke an ancient form of Hebrew. If the island's name was originally written in Hebrew, a right-to-left script, then the rendering would naturally appear as *Ha-Iti*. In Hebrew, *Iti-Ya* or *Iti-Ah* translates to "God is with you." This is similar in meaning to *Emmanuel*, which also means "God is with us." This overlap created confusion around the true meaning of these names.

In its pictographic or ancient Hebrew form, the name was rendered as YTI-AH. Interestingly, in Hebrew, the first-person conjugation of the verb "to be"—I AM—is also written *Hayiti*. While researching the Hebrew language, I found that many words have multiple meanings. Broken down, *Iti* means "earth" or "land," and *Ya* or *Ah* refers to God. Together, the name signifies: God's Land. Therefore, the term *Haitian* could be interpreted to mean God's People.

This mirrors the meaning behind the name *Emmanuel*, where *(Em)* means "inside," *(man)* is "man," and *(El)* is "God"—similar to *Ya* or *Ah*. Taken together, it means: "God is within this man."

Today, there are many attempts to uncover the meaning of the name "America." Yet, as shown in reports from the Smithsonian Institute, these efforts often encounter difficulties. The Aztecs—descendants of Mongoloid origin tracing back to Asia under the command of Genghis Khan—told stories of a peaceful people who built many of the region's great cities.

In the codices of the Incas and Mayans, the **Carib people**, known as the *Cakchiquels*, are described as having a great leader named **Mesi**—a name that would later become part of the word *Mexico*. During a key migration, four priests carried an idol named *Vitzilipuzli* in an arc. This deity promised them they would become rulers of nations. These people originated from the land of Judah—possibly *Utah*—and eventually settled in what is now Mexico. Some continued farther south, reaching the Peruvian mountains.

The **Olmecs**, great warriors of Aztlan (also known as the *Saladoides*), came from the Caribbean. They were said to be born from the union of two royal lineages: Queen Califa of California and King Solomon, son of Prester John, King of the Seven Indies. The Olmecs' primary mission was to recover the **Ark of the Covenant** and build a new temple for it. Many of their statues, most notably the **Olmec heads** found in Peru, remain as lasting testaments to their identity and legacy.

THE 2 TYPES OF PEOPLE IN THE NEW ISLAND

The islanders were divided into two main groups: the **Arawaks**, who are believed to be the **Olmecs**, and the **Tainos**, a Mongoloid people who arrived later and were identified by Europeans as the "Indians" of the islands. Spanish colonizers heavily emphasized the idea that the entire Caribbean was inhabited solely by Taino-speaking tribes. However, **Luis de Torres** (also known as Luis del Toro), Christopher Columbus's translator, recognized that the language spoken on the island of Haiti resembled an ancient form of **Hebrew**. He also noted that the people were described—through Paleo-Hebrew writings—as dark copper-skinned and physically beautiful.

Among these people were warrior tribes known as the **Maroons**, who served as protectors of **Queen Anacaona**—also known historically as *Ana Akhan*—of Léogâne. In the *English-Haitian Creole Bilingual Dictionary*, the phrase "the land is Kiskeya ou Boyo" is loosely translated as "Haiti love." However, its deeper meaning is understood to be "**The Mother of All Lands**" or "**Chief of All Lands**."

The people of Haiti were known as **Casique** (or *Kasin*), a term for leaders that may derive from Hebrew. These leaders were recognized across the Caribbean as chiefs over the other islands.

As European powers—Spanish, French, and English—began to expand their empires, they mobilized Indigenous peoples from North, Central, and South America into a system of **indentured servitude**, which over time evolved into what is now known as **slavery**. Haiti and Cuba became central hubs in this process, where families were separated and distributed to various plantations as a source of labor.

More than 500 tribes were relocated to Haiti, and just a year after the arrival of **Roman** Catholic invaders, the island began resisting. After four centuries of struggle—including victories over the French, Spanish, and English—Haiti eventually gained recognition as a sovereign nation.

Later historical narratives tried to depict the people known today as "slaves" as being exclusively imported from Africa. However, **modern research** into congressional records and commercial shipping data reveals that the actual number of Africans brought to the Americas was not as large as often claimed. In Haiti's case, most of the African individuals involved in the transatlantic trade passed through **Europe**, particularly **France**, before arriving on the island.

THE INTENDED REFERENCE

The term "Indigenous people" is where the name "India" is believed to originate. School history books often claim that Christopher Columbus set sail as part of a commercial mission to acquire spices from *India*. However, what history frequently omits is that the land we now call *India*—on the subcontinent of southwest Asia—was not originally known by that name.

In ancient times, the region was called **Bharat**, and its inhabitants near the **Indus River** were known as the **Sindhu people**. This raises an important question: Why did the English choose to colonize the land we know today as India? Was it as commercially promising as the Chinese opium trade? Or was it the lure of gold and access to a massive labor force that drove them? Regardless, after the British arrived in the 1700s, the name **India** became formalized and remained until their departure in **1947**.

Food for thought.

THE NAME'S ORIGIN STORY

In the Latin language of ecclesiastics and European royalty at the time, the phrase "Children of God"—a common way Spaniards referred to Indigenous peoples—translated loosely as "Los Niños de la Endeo." Over time, this phrase transformed through both linguistic simplification and cultural shifts.

- "En deo" in Latin means "of God."
- So, "Los Niños de la Endeo" meant "Children of God."
- The feminine form was "Las Niñas de la Endeo."

As Spanish usage evolved, this phrase was gradually altered:

- From "Los Niños de la Endeo"
- To "Los Niños de la Indio"
- Then shortened simply to "Indio."

The term continued to evolve in European languages:

- In Germanic usage: "Indianer"
- Then in English: "Indian"

This linguistic transformation is supported by the writings of **Bartolomé de las Casas**, a Spanish priest who passionately defended the rights of the Indigenous peoples of the Caribbean. In his appeals to the Spanish Crown, he referred to them using variations of the term "Niños de la Endeo". His accounts—and other historical reports—offer important

insight into how the terms "*Indio*" and "*Indian*" came to label the native peoples of the Americas.

Christopher Columbus set out with a clear goal: to find a western sea route to **India and China**, seeking valuable goods like **spices and gold**. His expedition was driven by both commercial ambition and tales of wealth in the East. Upon reaching the **Caribbean**, Columbus mistakenly believed he had arrived in **Asia**, which was a common misconception at the time due to the limited geographic knowledge of the world.

There is a common belief that Columbus was searching for the legendary **Seven Cities of Cibola**, also referred to as the "Seven Golden Cities." However, this particular myth emerged **later**, during the Spanish exploration of **North America**, especially in the accounts of explorers like **Francisco Vázquez de Coronado**. Once the Spanish realized they had not reached Asia, new legends of great cities filled with gold—like Cibola—began to spread, fueling continued exploration and conquest in the Americas.

While Columbus may not have explicitly searched for **Cibola**, his journey and the myth are closely linked in the broader context of European quests for wealth in the New World.

THE OUTSIDE ENLIGHTENMENT

Today, the **Maroons** still exist throughout the Caribbean, most notably in the **Blue Mountains of Jamaica**. In August 2017, during a trip from Ocho Rios to Kingston, my family and I stopped in a small village near Bob Marley's birthplace in the Blue Mountains. There, I met an old man who taught me something I will never forget.

He challenged my understanding of the Maroons. In Haiti, Maroons are often thought of as people who fled the cities to hide in the mountains. But according to this man, the Maroons were more than fugitives — they were a **tribe of hunter-gatherers**, **skilled in combat**, and intimately familiar with the land. He described them as **deeply spiritual**, choosing to live in the highlands to remain closer to the God they called **Yah**, away from the distractions of the world.

I had many questions, and his answers surprised me. He told me about **Dutty Boukman** (he mentioned another name I unfortunately can't recall), who was sent from Jamaica to Haiti to **awaken the people spiritually** and prepare them for a final uprising against the colonizers. I initially argued, assuming the famous ceremony at **Bois Caïman** was rooted in voodoo. He strongly disagreed, insisting, "Jamaican Maroons did

not mingle in that nonsense." He pointed to **Boukman's recorded prayer** as proof, saying that if the words didn't speak to and about the Creator, his claim would be false.

He was right.

After Boukman's prayer, the Roman powers responded. Henri Christophe, who had been sent by the Church as an infiltrator to divide the rebellion, assassinated Boukman and replaced him with a mambo to complete the ceremony. This marked the beginning of an alliance between Benin voodoo and Roman Catholicism on the island. These spiritual systems—Father God, Son of God, and Mother of Gods—parallel the voodoo divisions of Law, Rada, and Petro, working hand-in-hand to capture the spiritual energy of the Haitian people.

But what would happen if the people reactivated the **original spiritual covenant**—the one between **them and the Creator**—on this island?

THE BRAINWASH

On a personal note, my **paternal family roots** trace back to **Léogâne**, Haiti. The **Pauls**, **Vincents**, **and Christophes** are believed to descend from the coasts of **Togo and Ghana**, regions once known as the **Kingdom of Juda (Ya'uda)**—referred to in Haitian tradition as **Gin'in**, commonly equated with Africa. Interestingly, Haitians identify **Gin'in** with the African continent, while **Guiana** exists in **South America**, further blurring the lines of migration and naming.

There are also **biblical place names** scattered across the Americas: **Uudah, Yerusalem, Califa**, even the **Red Sea**. Add to that references to **Ethiopia**, **the Three Indias**, and other terms we now associate with distant lands, and a fascinating cultural map begins to emerge.

According to family history, our ancestors were taken to **France**, where they were subjected to **cultural conditioning**intended to manage and pacify the island's native people. They were re-educated through **French religious and aristocratic systems**, which emphasized **class division** and a sense of **superiority**. From the colonizers' perspective, this made sense. Many enslaved Africans had **knowledge of Hebrew**, which allowed for a transition from **Hebrew to French**, eventually giving rise to the **Creole language**, a sub-pidgin used for control and communication.

1. CHRISTOPHER COLUMBUS

The involvement of **Moors and Jews** in the conquest of the Americas—also known as **Turtle Island**—is significant. **Christopher Columbus** was backed by **Jewish financiers**, coming from a lineage of **mercantile families** similar to that of **Marco Polo**. The **Moors**, many of them **prisoners of war**, served as part of the boat crews. For some, the voyage may have presented an opportunity to reclaim lands from which they had once been expelled.

In "the Diary of America with remarks on its institution, Part 2", by Captain Marryat, CB volume 3, the reference letter of Christopher Columbus is used to illustrate the people of the Island of Haiti.

Upon the discovery of America by Columbus, nearly 2000 years after the dispersion of the Hebrew tribes, the entire continent was found to be populated not by wild or savage people but by a race of intellectual, moral, and innocent individuals, spread across hundreds of nations and spanning over 8000 miles of territory. 1. LET'S RECAP: WHO AND WHAT IS HAYITI

Haitians represent a diverse mix of various Caribbean, Central, North, and South American tribes. Their Creole language has its roots in Hebrew. Interestingly, the name "HAITI" has a pictograph that, when written in Hebrew, appears as "ITI-YAH," signifying "God's land." JEWISH-JEWS

These writings highlight a people oppressed, enslaved in their own land, yet still holding onto hope for liberation.

JEWS OF THE LAND OF ISRAEL

In *The 13th Tribe*, Arthur Koestler argues that many modern Jews descend from the Khazar Empire, a powerful kingdom in the Caucasus from the 7th to 10th century. The Khazars reportedly adopted Judaism and learned Hebrew from Canaanite-descended Phoenicians. They became fluent in the language and influential in European financial systems, often acting as neutral intermediaries. Similar financial influence reappeared from the 1400s through WWII, especially as Jewish banking families gained power in England.

JEWISH IDENTITY AND DNA

How can DNA be manipulated?

DNA doesn't determine geographical or political identity. It can only show genetic similarities when compared to other samples. The Khazarian claim to Canaanite roots is inaccurate. While the Canaanites influenced the Phoenicians and spread Hebrew into the Caucasus, the Khazars themselves descend from tribes like the Huns, Uyghurs, and Magyars—lineages from Japheth, not Abraham, Isaac, or Jacob.

ASSUMPTION ERROR

The mistaken belief that Khazarian Jews are the original Hebrew people of *Turtle Island* (a term used for the Americas in some Indigenous traditions) fueled efforts to reclaim lands once inhabited by Moors. By adopting this identity, they positioned themselves as "God's people," gaining global support—especially from the United Nations.

The Rothschild family, Ashkenazi Jews, were instrumental in the establishment of modern Israel. Backed by the UN, they secured control over Palestine, creating a new state and igniting long-standing conflict between the new settlers and the original inhabitants.

THE MOORISH INTENT

According to Procopius of Caesarea, the Moorish tribes are direct descendants of the Canaanites who took refuge in the land of Libya. Often, when the land of Canaan is mentioned, people envision the modern-day Palestinian region depicted in Bible maps. However, that is not the region being referred to here.

Let's review: Canaan was the son of Ham and the grandson of Noah. After Noah cursed Canaan, he eventually settled in the land of Shem—a place his father Ham had warned him against. Joshua, a descendant of Shem, later led a conquest to reclaim the land, driving out the Canaanite descendants.

In North Africa, the Pharaoh of Mississippi—*Mississippi* meaning "Niles"—granted territory to both the Canaanites and Moabites. From there, the Moors built a powerful empire across Mauritania, Tunisia, Algeria, Morocco, Libya, and even into Spain. Meanwhile, the Phoenicians—who were also Canaanite descendants—occupied areas of Palestine and later moved into parts of northern Europe.

Over time, some Phoenician descendants clashed with the Moors in Spain and succeeded in expelling them in 1491. Many captured Moors were given a choice: sail with Christopher Columbus and join his expedition to reclaim the land of Shem—this time backed financially by Jews and politically by Queen Isabella, with the promise of gold and a belief that the land could be taken.

THE PHOENICIANS


The Phoenicians were known for their ruthlessness, mastery of sea navigation, and dominance in global commerce. They are credited with inventing currency—what we now know as money—and spreading linguistic systems to the regions they controlled, such as parts of Turkey, Greece, the Caucasus, and broader Mediterranean and Western Europe.

They settled in present-day Lebanon and founded the religious city of Byblos, where they used papyrus as a metaphysical and cultural medium. This influence contributed to the Greek naming of the *Bible*, originally referring to "books."

Through the guise of commerce, the Phoenicians introduced several foundational legal systems. One of the most influential is **Maritime Law**, which has had a global impact. In the United States, this evolved into what is known as the **Uniform Commercial Code (UCC)**.

To facilitate trade with the many lands they encountered, the Phoenicians helped develop **Trade Languages**, commonly known as *Pidgin Languages*. These simplified languages were based on existing European tongues—especially **Lingua Franca** and Dutch—and eventually evolved into modern English. English, in turn, gave rise to several derivative languages, including Latin-based creoles and dialects.

These trade languages introduced phonetic and grammatical patterns that can still be traced today. Once their root meanings are understood, it becomes evident how the manipulation of spelling and sound shaped the development of creoles and regional dialects across the world.



THE ALPHABETS ORIGINATION AND DEVELOPMENT

THE START POINT

The Phoenician alphabet is the basis for most western languages written today and their city of Gebal (called by the Greeks 'Byblos') gave the <code>Bible</code> its name (from the Greek <code>Ta Biblia</code>, the books) as Gebal was the great exporter of papyrus (bublos to the Greeks) which was the paper used in <code>writing</code> in ancient <code>Egypt</code> and Greece. It is also thought that many of the gods of ancient Greece were imported from Phoenicia as there are certain indisputable similarities in some stories concerning the Phoenician gods Baal and Yamm and the Greek deities of <code>Zeus</code> and <code>Poseidon</code>. It is also notable that the <code>battle</code> between the Christian God and Satan as related in the biblical Book of Revelation seems a much later version of the same conflict, with many of the same details, one finds in the Phoenician myth of Baal and Yamm.

PHOENICIAN AND HAZARIAN JEW LETTERS EVOLUTION

Early Semitic "Ancient Hebrew" font

This is the original pictographic script used by all Semitic peoples, including the Hebrews, prior to 1200 BCE.

Moabite Stone (Middle Semitic): This is the script used on the Moabite stone, which is written in Moabite, virtually identical to the Hebrew language and the Paleo-Hebrew script.

Paleo Hebrew (Middle Semitic): This is the Hebrew alphabet that was in use from about 1200 BCE and into the first century CE.

DSS Hebrew (Late Semitic): This is the Hebrew script used in the Great Isaiah scroll and is representative of the Hebrew found in most of the Dead Sea Scrolls.

Writing was originally developed as a tool for government and religious control—to unify thought and standardize beliefs. Its power lies in how it binds people, often without their awareness. For example, Latin, one of the foundational written languages, has historically

been used to entangle individuals in legal or religious contracts they did not fully understand. In this light, ancient, unwritten languages—rooted in thought, intent, and spirituality—may hold more truth and power than modern tongues. Or perhaps, writing itself became a tool of confusion—keeping people at a disadvantage. Just consider the day you must appear in court and pay thousands to a lawyer simply to interpret a language you speak daily, yet don't fully understand.

EUROPEAN AND MEDITERRANEAN LANGUAGES

As seafaring masters of commerce, the Phoenicians developed an alphabet to facilitate record-keeping, contracts, intellectual exchange, and cultural adaptation. This alphabet laid the foundation for several languages, including Greek, Latin, Arabic, Cyrillic, and what is now called the "Khazarian" form of Hebrew. These languages evolved from commercial necessity, not cultural completeness. As such, they represent what might be called a **Babel formula**—languages of confusion.

In contrast, **Hebrew** is described as a language of purity—formed from intent and thought, not utility.

THE START OF LANGUAGES

According to ancient texts, Nimrod (also known as Gilgamesh), the world's first emperor, attempted to unite all people against God by building the Tower of Babel. It is said that what Nimrod envisioned was entirely achievable. The tower—reportedly so massive it took a year to ascend—represented the height of human ambition and unity.

But God intervened. He confused their language, scattering the people across the earth and giving birth to the many languages we now know. One man, **Heber**, refused to participate in the construction and took his family across the great river. In doing so, he preserved his spiritual purity and entered into a covenant with God. This marked the beginning of the Hebrew lineage—a people promised abundance and divine favor.

POLYSYNTHESIS AND LINGUISTIC REDUCTION

In 1816, French linguist **Peter Du Ponceau** observed that English simplifies communication by compressing many ideas into few words. His study, **Memoir on the Grammatical Systems of the North American Indian Languages**, showed how native languages—often rooted in Hebrew structure—were stripped of complexity to

create more generalized, familiar-sounding forms. This process diluted rich vocabularies and imposed linguistic control.

Later, anthropologists like **Franz Boas**, **Melville Herskovits**, and **Margaret Mead** supported this linguistic simplification, arguing it helped integrate and manage populations. But the result was a profound **dumbing down** of society. Mead once remarked:

"We train people not to be able to learn foreign languages in the most fantastic way... We teach a child: 'This is a pencil.' But this isn't a pencil—it's an object, made of wood and lead, designed for writing, which we *call* a pencil. Others call it different things."

This speaks to the disconnect between name and essence—a loss of meaning through language.

Interestingly, in 1780, **John Adams** proposed English be made the official language of the United States. Congress rejected the proposal as undemocratic. Instead, on **March 3, 1819**, Congress passed the *Act for Civilizing the New Frontier*—a legislative move to facilitate commercial expansion, not cultural preservation.

SUMMARY

The Canaanites once lived in the land of Shem. After being displaced, they created their own version of history—casting **Joshua** as the villain. This counter-narrative took root, and for generations has shaped public perception. By reshaping history and simplifying language, they imposed a version of reality that distanced people from their spiritual heritage.

The remaining 10%—our spoken words—has been reshaped into **pidgin** languages. These languages, simplified for trade, became tools of **deception in commerce**. Today, we live in a world where language often conceals more than it reveals.

THE ROMAN "JEWS, MOORISH, AND PHOENICIAN" LAWS

HOW DID A CONTINENT NOT AT WAR INHERIT THE TITLE OF SLAVES?

We are taught in school that Europeans arrived in Africa and began buying and capturing Africans. But the deeper question is: *What gave them the right to do so?* The answer lies in centuries-old religious decrees, legal fictions, and commercial codes that transformed free peoples into commodities.

HISTORICAL BREAKDOWN

In 1075, an English reconnaissance ship named *The Good Jesus* landed on the West African coast—specifically in the **Kingdom of Judah**. Its first greeting to the locals was "**Shalom**," affirming a Hebrew-speaking presence in Africa. This kingdom, over time, became known as **Guinea**, and today is divided into **Togo** and **Ghana**. This detail challenges conventional narratives and reinforces the historical presence of Hebrew tribes in Africa.

THE ILLUSION OF POWER: CRUSADES AND ENSLAVEMENT

It took five years for **Pope Urban II** to initiate the Christian Crusades. Between 1095 and 1492, after six major campaigns, the **Roman Catholic Empire** seized Jerusalem from those they labeled "Islam"—meaning "those who submit to the will of God." Importantly, this *Islam* was not the later religion founded by **Mohammad in 622 CE**, but rather a term historically referring to *the Children of Israel*.

Following these victories, **Pope Benedict** issued the **Fourth Lateran Decree**, granting moral and legal authority to Christian monarchies to enslave any who resisted conversion. These decrees empowered France, Spain, England, and Portugal to acquire slaves through trade or force—**under the cover of Maritime Law**. This legal mechanism became a tool for religious conquest and commercial exploitation.

THE DOCTRINE OF DISCOVERY

The **Doctrine of Discovery** was articulated in U.S. law during the case **Johnson v. M'Intosh** (1823), where **Chief Justice John Marshall** ruled that only Christian European powers could claim sovereignty over non-Christian lands. This doctrine invalidated indigenous land claims globally and became the legal foundation for colonization.

This principle remains controversial and is increasingly scrutinized by modern legal scholars as a tool of historical injustice.

CONSENT WITHOUT KNOWLEDGE

How can the state take your children without a court battle? The answer lies in **contractual consent**. When parents sign a birth certificate, they unknowingly enter a **unilateral contract** with the state, granting it jurisdiction over the child. Rhodes is recognized as the birthplace of maritime law, originating in the **Rhodian Sea Law** (7th–8th century CE). This body of law governs private shipping, open-water offenses, and international trade. By the **1807 French Code de Commerce**, maritime law became part of general commercial law, with local courts taking over where Admiralty Courts had been dissolved.

Understanding these laws matters because, legally, **birth is treated as the delivery of a vessel**—placing individuals under **Maritime jurisdiction** from birth. This religious-commercial classification stems from papal authority and continues to impact legal systems today. For example, **Haiti** still operates under outdated French maritime codes, undermining its sovereignty.

Even though people are sovereign, their governments are bound by **external commercial systems** such as the **IMF**, which require nations to commercialize their populations to stay solvent. This is evident in birth certificates, the use of capitalized names, and other legal fictions.

ALL IS COMMERCE

People are classified under commercial law unless they **assert their sovereignty**. This is why court cases often revolve around **money**, **debt**, **or energy exchange**.

Commerce—defined as the exchange of goods and services—includes not just trade, but everything that facilitates it: storage, packaging, financing, transportation, and regulation. It links producers to consumers and is essential for economies, but also serves as a **control mechanism**.

ARE THESE CONSTITUTIONAL LAWS BIBLICAL?

Consider the U.S. Declaration of Independence:

"We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights..."

Significant differences exist between the **God of the Bible** and the **deified constructs** introduced by Roman Catholicism. One major alteration lies in the translation and interpretation of names and divine figures.

For example, the name "Jesus" or "Yesus" appears exclusively in the Masoretic Text-based translations, yet its etymology stems from Greek and possibly even Creek Indian phonetics. In contrast, the Septuagint (Greek Old Testament) and other early texts reference the Messiah as Emmanuel. While traditionally translated as "God with us," a more accurate rendering could be "God is within this man," emphasizing divine indwelling rather than proximity.

This interpretation differs drastically from the later doctrinal formation that equates "Jesus" with the "Son of God" in a **Romanized Trinitarian theology**, where sun worship symbolism (often hidden) was syncretized into Christian beliefs.

Furthermore, names like **Yahawashi** or **Yahshua**—believed by some to be closer to the original Hebrew name of the Messiah—are distinct from **Jesus**, whose phonetic construction aligns more with Greco-Roman deity references (such as **Zeus**, **Iēsous**, etc.).

THE TRINITY DEBATE

The **doctrine of the Trinity**—one God in three persons (Father, Son, and Holy Spirit)—is a **Christian theological construct** that does not appear explicitly in the Bible. While some churches compare the Trinity to the body, mind, and spirit within a human, the **biblical texts consistently maintain the distinction of entities**, especially the **primacy of the Father (YHWH/Yahawah)**.

The **Bible advocates monotheism**, with repeated commands to give glory and worship exclusively to the **Father**, not to a triune entity. The Trinity, therefore, represents **a theological addition**, not a foundational scriptural truth.

BAAL WORSHIP AND GOVERNMENTAL STRUCTURE

The structure of modern governments—particularly in the West—owes much to **ancient pagan systems** rooted in **Baal worship** and **Mesopotamian law codes**. Consider the following breakdown:

- 1. Government Branches Based on Cuneiform Law:
 - Congress
 - Senate

- House of Representatives
- 2. Territorial Divisions Derived from Pagan Systems:
 - Metropolises
 - Cities
 - Megalopolises
- 3. Social Classification:
 - Codified by Hammurabi's Code, this system divided people into legal and class structures, enforcing control through law, fear, and hierarchy.

These frameworks were designed to sustain **power through confusion**, **chaos**, **division**, **and discrimination**—traits closely aligned with the biblical concept of **Babylon**, the symbolic system of confusion.

SUPREME LAW: BIBLICAL VS. CONSTITUTIONAL

According to Scripture, the **true "Supreme Law"** is concise and universal—particularly evident in the **last five commandments** of the **Ten Commandments**, which regulate behavior toward fellow humans:

- Honor your parents
- Do not murder
- Do not commit adultery
- Do not steal
- Do not bear false witness

These moral laws transcend culture and language, forming the ethical bedrock of many civilizations.

Yet, a conflict arises when comparing **biblical moral law** with the **U.S. Constitution's Supremacy Clause**, which declares:

"The Constitution, and the Laws of the United States... shall be the supreme Law of the Land."

However, this supremacy is conditional—only valid if consistent with the Constitution itself. Here lies the contradiction: while claiming supremacy, many laws enacted under the Constitution contradict biblical kingship and theocratic governance, instead reflecting Babylonian legal traditions.

COMMERCIAL CODES AS BIBLICAL DERIVATIVES

Laws governing **modern man**—particularly in the U.S.—operate primarily under **commercial law** (UCC/Maritime Law), which itself borrows structurally from biblical concepts of contract, debt, and obligation. Yet these systems have evolved into **instruments of control**, distorting the original spiritual intent behind biblical laws.

Examples:

1. Under the Laws of Commerce, Truth is Sovereign

The foundation of the Uniform Commercial Code (U.C.C.) is Commercial Law. The foundation of Commercial Law is based upon certain universal, eternally just, valid, moral precepts and truths. The basis of Commercial Law is the Law of Exodus (i.e. The 10 Commandments) of the Old Testament and Judaic (Mosaic) Orthodox Hebrew Commercial law. The Laws of Commerce have remained unchanged for at least six thousand years and form the basis of western civilization, if not all nations. This law of commerce therefore applies universally throughout the world. Real Commercial Law is non-judicial and is prior and superior to, the basis of, and cannot be set aside or overruled by the statutes of any government, legislature, governmental or quasigovernmental agencies, courts, judges, and law enforcement agencies, which are under an inherent obligation to uphold said Commercial Law. Commercial Law is a "War of Truth" expressed in the form of an intellectual weapon called an Affidavit. An Affidavit is merely a written list of facts or truths signed under penalty of perjury and usually notarized. The person composing and signing an affidavit is called the "affiant". It is "survival of the fittest" where the last unrebutted stands triumphant.

In the Laws of Commerce, the eternal and unchanging principle of the law are:

- 1. A workman is worthy of his hire. Authorities: Exodus 20:15; Lev. 19:13; Matt. 10:10; Luke 10:7; II Tim. 2:6. Legal maxim: "It is against equity for freemen not to have the free disposal of their own property.
- 2. All are equal under the law (God's Law-Moral and Natural Law). Authorities: Exodus 21:23-25; Lev. 24:17-21; Deut. 1:17, 19:21; Matt. 22:36-40; Luke 10:17; Col. 3:25. Legal maxims: "No one is above the law."; "Commerce, by the law of nations, ought to be common, and not to be converted into a monopoly and the private gain of a few."
- 3. In commerce, truth is sovereign. See Exodus 20:16; Psalm 117:2; John 8:32; II Cor. 13:8. Legal maxim: "To lie is to go against the mind." Oriental proverb: "Of all that is good, sublimity is supreme."
- 4. Truth is expressed in the form of an Affidavit. See Lev. 5:4-5; Lev. 6:3-5; Lev. 19:11-13; Num. 30:2; Matt. 5:33; James 5:12.
- 5. A matter must be expressed to be resolved. See Heb. 4:16; Phil. 4:5; Eph. 6:19-21. Legal maxim: "He who fails to assert his rights has none."

6. An unrebutted affidavit stands as truth in commerce. See 1 Pet. 1:25; Heb. 6:13-15. Legal maxim: "He who does not deny, admits."

This is the basis of public law VS Private laws. Remember that the private laws that drive the commercial understanding of men supersede all other laws. However, your Status cannot be under the District of Columbia Jurisdiction. This is where the term Sovereign and rights clashes. According to the Bar Association no one should deviate from its bind, if one tries then one should be labeled as an anti-government. However, understanding and knowledge, which helps from past mistakes should give you the incentive to own your name, rights and future ei: wealth.

IMMUNITY LAW

These laws refer to the authority of the creator given to men. These laws gave birth to statues with their own jurisdiction, where all RIGHT belonging to oneself has been acknowledged, filed and maintained forever. If this is not done the JURIS EMINENT PERSONALITIES can take place or Cestui que vie trust will apply as default and make you warden of the court: no entity or man would have a say over his or her life.

CESTUI QUE VIE TRUST (HE WHO LIVES)

London **1666**, during the black plague and great fires of London, Parliament enacted an **act** behind closed doors, called **Cestui Que Vie Act 1666**. The **act** being debated was to subrogate the rights of men and women, meaning all men and women were declared dead, lost at sea/beyond the sea.

REBUTTABLE PRESUMPTION⁷

Conspiracy theorist on the "Cestui Que Vie Act 1666" implies that state ownership of their body applies via the birth registration process, and unless this presumption is lawfully refuted before the time period of seven years elapses after registration, they become the property of the state, having been declared legally dead, or "lost at sea".

This is quite a fantastical proposition, based on abstract speculation regarding the intention of the 1666 Act. It is the foundation for the version of "Maritime Admiralty Law" which is the jurisdictional reason for the enforceability of statute law.

At that particular time in history, many English people were "over the seas" mainly involved in the Anglo-Dutch wars. When they went missing overseas, presumably killed in battle or by piracy, and never returned, it caused a legal dilemma for their families back in England, mainly because of inheritance issues being stalled indefinitely. Often their estates and properties were declared abandoned, and handed over to the church, denying their descendants their rightful inheritance. It was for these
